- Ensures that quality systems are established, implemented and maintained in compliance with GPP and GMP;
- Act as a key quality assurance person and manage the QA team;
- Perform internal and external quality audits; coordinate and prepare site for Health Canada and other regulatory inspections;
- Ensure that complaints, deviations, non-conformances, investigations, corrective and preventative actions and change control are performed according to quality and regulatory requirements;
- Develop and maintain raw material supplier qualification process;
- Perform material review and determine batch disposition;
- Manage the Pest Control and environmental monitoring process;
- Manage the SOP, document approval and control process;
- Manage the Sanitation program;
- Manage delivery of training for GPP and GMP compliance as required;
- Other duties as required.
