- Assist in the oversight of all cannabis related activities such as cultivation, drying, packaging, and destruction to ensure adherence to the Cannabis Regulations and Cannabis Act, GPP (Good Production Practices), and SOP (Standard Operating Procedure) requirements.
- Develop and conduct internal compliance audits of operations as it pertains to the regulated cannabis industry (Physical Security, GPP, and Cannabis Traceability).
- Assist with monthly, quarterly, and annual CRA Excise tax reporting requirements.
- Assist Compliance department in preparing for and during Regulatory audits (Health Canada and CRA);
- Provide oversight of compliance assessments for all document, product, and process changes.
- Assist in company-wide risk management and mitigation practices.
- Assist in planning, implementing, and overseeing risk-related programs
- Familiarize with and understand the regulatory requirements from Health Canada
- Actively review new regulatory updates and communicate relevant information
- Work closely with the Quality Assurance Team, Accounting Department, and Production Managers to develop regulatory strategies to uphold compliance
