
PURE SUNFARMS

Driven by a love of plants, Pure Sunfarms produces high-quality, BC-grown cannabis for the Canadian market. Our deep farming roots combined with a legacy of cannabis cultivation and knowledge of growing at scale, embedded from our parent company Village Farms, guides our uncompromising approach to quality.

We select our strains based on flavour, potency, and their ability to thrive in our sunlight-filled, 1.65 million square foot high-tech greenhouse space in Delta, British Columbia. Our cultivation team has collected detailed sunlight and environmental information at this location in BC's Fraser Valley for more than a decade, which gives us an incredible depth of knowledge to adjust our cultivation practices on a plant-by-plant basis.

We use a modern growing approach which allows for the control of heat, light, and energy the sun brings to maximize the potency potential of our plants. In this very precise environment, cannabis flourishes; sectioned into growing rooms that let us nurture plants at each stage of development differently through app-based monitoring. This way, our hands-on growing team can ensure our plants get exactly what they need to produce consistent and aromatic quality cannabis, grown with care, all year rounds

- Pure Sunfarms is one of the largest cannabis operations in the world with
 2.2 million square feet of greenhouse space in Delta, British Columbia.
- The company currently operates within 1.65 million square feet, and has
 capacity to produce, sell and distribute 112,500 kilograms of
 high-quality, BC-grown dried flower annually for Canadian recreational
 and international markets, with the ability to expand annual output to
 150,000 kilograms as needed.
- The company brings together decades of agricultural and legacy cultivation experience with best-in-class, large scale operational expertise, and is Canada's top-selling brand.
- Pure Sunfarms currently offers cannabis products in a number of categories, including: dried flower, edibles, concentrates, pre-rolls, pre-ground, vapes, seeds, and oils.
- Pure Sunfarms products are available in Ontario, British Columbia,
 Alberta, Saskatchewan, Manitoba, Yukon, Northwest Territories, New
 Brunswick, and Newfoundland and Labrador at participating retailers and
 online through each region's respective distributor where applicable.
- Pure Sunfarms also provides cannabis to its affiliate ROSE LifeScience in Québec, other licensed producers in Canada, and is EU GMP and IMC-GAP certified to export product to international markets.
- Pure Sunfarms received Health Canada approval in March 2020 to operate a 65,000 square foot state-of-the-art processing center designed to satisfy full European Union GMP compliance and certification requirements.
- The company received amended licensing from Health Canada in September 2020, which permits in-house extraction operations and the sale of cannabis oils and derivative products directly to provincial/territorial boards and authorized retailers.
- Pure Sunfarms is the licensed producer of record for Pure Sunfarms, The Original Fraser Valley Weed Co., Soar, and Nowadays.
- Pure Sunfarms is a wholly owned subsidiary of Village Farms International, Inc. (Nasdaq: VFF).
